ORGANIZATION'S PRIMARY EXEMPT PURPOSE:

To sponsor participation in college preparatory programs and to provide university scholarships for young Liberian adults who were academically disadvantaged by the 14 year civil war in Liberia.

PART III:

ORGANIZATION'S PRIMARY PROGRAMS:

SCHOLARSHIP PROGRAM:

Activities include ongoing review and refinement of university scholarship program goals and structure, equal opportunity policies, application, and terms. A total of 57 students received academic scholarships in 2013, including 4 high school students, 20 students attending one of five carefully selected Liberian partner universities, and 33 in a Technical/Vocational (TVET) program studying plumbing, masonry, and carpentry. RYHF celebrated 2 graduates in 2013 in Agriculture (1) and Teaching (1).

The remaining 55 students continue to maintain the required high academic standards for scholarship, pursuing careers identified as being in critically short supply in post-war Liberia. To maximize student safety and success, support services are made available as needed to scholarship recipients, RYHF Student Association members, and RYHF alumni. These services include tutoring, individual academic and personal counseling, and aid with emergency life circumstances (loss of health, home, or resources). Through the RYHF scholarship program, individuals and their families benefit and RYHF is contributing to the nation's re-building goals.

RAISE YOUR HAND FOUNDATION STUDENT ASSOCIATION (RYHF-SA), LIBERIA:

The vision for RYHF-SA is to maximize individual potential, support student success on college campuses, and to give back to the community through volunteerism. RYHF-SA was founded in 2009 at Cuttington University (CU) in Suakoko, Liberia, and was officially recognized as a campus organization by administration on February 26, 2010. Since its inception, the CU chapter has hosted campus-wide leadership seminars, college fairs for regional high school students, peer tutoring programs, and campus beautification projects. In March 2013, the members of RYHF-SA at CU hosted a school-wide leadership skills development conference, including dozens of local community leaders as participants. Per the goals of 2012, Cuttington RYHF-SA also worked with students at Stella Maris Polytechnic, Monsignor Stephen Kyne Technical College in Monrovia to organize a chapter on their campus. More than 40 students comprise the founding membership at Monsignor and development continues to date.

RAISE YOUR HAND FOUNDATION ALUMNI ASSOCIATION:

The RYHF Alumni Association was officially launched in March 2013 and a communications forum hosted by leadership to discuss possible activities of the association, mentoring opportunities, and potential professional partnerships with RYHF and local NGOs. Development continues.

CALVARY REVIVAL COMMUNITY SCHOOL (FREETOWN, VIRGINIA, LIBERIA):

In 2013 RYHF continued its community service partnership with Calvary Revival Community School. In early 2013 an American investor provided funding to construct a 14 classroom school building and upon completion in July, the name of the school was officially changed to the John Christian International School. RYHF donated educational materials and developed a plan and timeline to help the school's administration and volunteer staff meet Liberian government requirements for accreditation within the designated grace period. RYHF provided the principal with an immediate scholarship to complete his Education Administration BA degree and began development of an on-site teacher certification program to be initiated in 2014.

DANJA FISTULA CENTER AND LEPROSY HOSPITAL, NIGER REPUBLIC:

This community service partnership was launched in November 2012. One of the RYHF Advisors to the Board serves as Executive Director of the Danja medical facilities in Niger. In 2013 RYHF worked with the Lions Club (Folsom Lake Project for the Visually Impaired) to send several boxes of refurbished, donated eyeglasses to the Leprosy Hospital. This project is ongoing - shipment strategies to reduce costs continue to be refined.
