AWP has established three field offices, two in Georgia and one in South Carolina, out of which 11 trained advocates provide services. At this writing, AWP had 3769 total warriors known to the Project. A total of 1823 new warriors enlisted AWP in 2013, of which 919 warriors were connected to holistic support to improve their quality of life. The year-to-date accomplishments include permanently housing 88 formerly homeless veterans, assisting 84 warriors with utility bills through Georgia's Project Share, supporting 31 warriors with furniture for permanent homes, helped 1 previously homeless warrior purchase their own home, enrolling and sustaining in school 667 warriors, finding jobs for 94 unemployed veterans, assisting 59 warriors with new benefit claims, referring 222 warriors to non-veteran support, had 19 warriors awarded Veterans Affairs benefits, and obtaining 2 car donations through Mechanics Ministries. In order to accomplish the mission of supporting warriors it was critical to conduct outreach events. The largest of the many events was Thunder Over Augusta where Gary Sinise and the Lt. Dan Band performed before 25,000 warriors, families, and community partners.
