The Small Wild Cat Conservation Foundation (SWCCF) was involved in 12 small cat conservation projects around the world. These projects in New Mexico, Chile, Thailand, India, Mexico, Java, Kazakhstan, Scotland, Sumatra, Sri Lanka, Uzbekistan, and Bhutan.

SWCCF works with small wild cat conservationists to discover and mitigate threats to small wild cats.

In New Mexico SWCCF worked with US Fish & Wildlife on several wildlife monitoring projects where bobcats and pumas were recorded (\$302.60).

In Chile SWCCF checked camera traps that recorded Andean cat and Pampas cat (\$2500.00).

SWCCF forwarded a donation to Thailand for fishing cats (\$247.65).

In India SWCCF contributed to a fishing cat conservation project (\$2500.00).

In Mexico SWCCF helped a project involved with bobcat, ocelot, jaguar, and puma (\$3600.00).

In Java SWCCF continued to search for the elusive and perhaps extinct fishing cat (\$7575.00).

In Kazakhstan, SWCCF contributed camera traps to look for Pallas' cat (\$11263.71).

In Scotland SWCCF contributed camera traps to look for Scottish wildcat (\$5660.95).

SWCCF worked with colleagues in Sri Lanka who are involved with fishing cat conservation (\$200).

In Bhutan SWCCF gave two camera trap data workshops (\$60.75).

In Uzbekistan SWCCF helped a Wildlife Conservation Network partner working on behalf of saiga antelope where our cameras recorded caracal (\$1812.57).

In addition, SWCCF continue development of the book "A Monograph of the Felidae" (\$8300.00).
