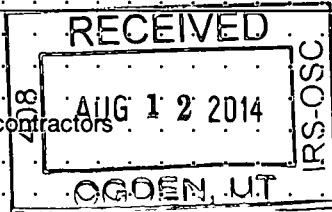

**PART 1 - EXPENSES**

10 Grants paid considers almost in its totality flight and travel expenses for the speakers at the Creatio Conference in Rio de Janeiro. Some speakers were generous and wealthy enough to pay for their own expenses and other speakers were already in Brazil for the event anyway. Creatio paid for the flights of 8 speakers, coming from the USA, Europe, Peru and Brazil. No speakers were paid or remunerated in any way, except for covering the costs they required to attend.

16 Other expenses includes accessory travel costs for mission trips and trip leaders, and meals, project materials for partners in mission trips and service projects. For example for mission trips the community leaders are invited to a special farewell celebration, the mayor or Bishop are offered a relief painting/ artwork, all gestures important and expected for participatory community development in the third world. Also include travel costs for trip leaders to survey projects and attend conferences in preparation for mission trips or for the volunteers in Rio de Janeiro to prepare for the event. The stage for the Conference in Brazil was paid by another group but Creatio contributed \$1000 plus the cost of lighting. Also included here are costs to Washington DC for a Catholic conference used for networking and promotion of mission trips. A video made after the conference in Brazil cost \$4000.
