ACCREDITATION: By the end of 2013, GFAS had accredited/verified 154 sanctuaries and rescues. GFAS also awarded a total of \$48,270 in compliance grants to assist organizations in becoming accredited or verified.

ANIMAL RESCUES/TRANSPORT PLACEMENTS: In 2013, GFAS assisted in the placement of more than 300 animals in need. Often these animals come from failed roadside zoos, owner surrenders or even failed sanctuaries. GFAS also assisted with the placement of 2000 macaques.

STANDARDS, KEY PRESENTATIONS AND OTHER OUTREACH: In 2013, GFAS achieved many program and outreach accomplishments. GFAS launched a new website designed to provide many more resources to sanctuaries and rescues around the world. A second and linked website was also launched for a program of GFAS, the Captive Wild Animal Protection Campaign, which serves to provide educational materials to better inform the public about captive wild animal issues.

GFAS accomplished an extensive review, edit and reformat of all standards and applications for 23 species of animals providing what is essentially state-of-the-art "best practices" and knowledge. In 2013, GFAS also

published its first series of quarterly newsletters and an annual report to better inform others of our work.

Many workshops were presented and co-hosted in 2013. GFAS presented at 6 workshops across the country with ASCPA in the Schaefer Family/ASCPA Equine Fund Workshops for equine rescue organizations. Also, GFAS co-hosted, with the International Fund for Animal Welfare, the first national Big Cat workshop. Twenty-one big cat sanctuaries for fifteen states were in attendance. GFAS attended and presented at the 5th annual Wild Animal Rescue Network (WARN) conference in Malaysia which brought together sanctuaries from locations throughout Asia. GFAS staff also presented at the North American Primate Sanctuary Alliance (NAPSA) and the Animal Grantmaker's conference. Many webinars were hosted including topics such as grant-making and how to become nationally accredited.
