THE ORGANIZATION GENERATED FUNDING TO BENEFIT COUNTY PARKS, FACILIATED ARRANGEMENTS WITH VOLUNTEERS AND OTHER ORGANIZATIONS FOR COOPERATIVE WORK EFFORTS AND ADVOCATED FOR PARKS AND OPEN SPACES Our annual fundraiser, the Flagstaff Wine & Food Festival, is now a recognized summertime event in Northern Arizona In 2013 attendance at the festival increased by 60%, over 100 volunteers were involved and 30 domestic and international wineries participated along with 10 of Northern Arizona's finest restaurants The event also included high-end craft beer tasting from five breweries and sampling of 14 varieties of spirits We successfully operated the Beer/Wine Garden and the Home brew Competition at the 2013 Coconino County Fair for the third year in a row, providing friendly and helpful customer service and a great selection of drinks We have two legacy funds The late Bruce Mason, a founding Board member, left \$575 to be used for the improvement of the County Fair The family of Michael Lunn established a fund to be used for the improvement of trails This fund has a current balance of \$2,800 with annual donations being made by various family members on the anniversary of his death We completed the funding of our \$5,000 grant to Coconino County Parks and Recreation toward the completion of Segment 20 of the Flagstaff Loop Trail
