The Media Program includes an online video and social media campaign; a project whereby copies of a hardcover book with "it gets better" testimonials are donated to school and community libraries; and various television, radio and print journalism programs.

COMMUNITY ENGAGEMENT PROGRAM: The It Gets Better Project works directly in communities and collaborates with other organizations to connect LGBT youth with the resources they need, and to leverage the Project's mainstream recognition to raise awareness and inspire change. The Community Engagement Program includes an online resource center to connect LGBT youth with local resources; a program to support the efforts of legal services organizations working to improve the lives and circumstances of LGBT youth; and a range of collaborative activities with different organizations with the goal of making things better for LGBT youth.
