THE BOARD OF DIRECTORS OF
FITSCHOOLS FOUNDATION

The undersigned, being all of the Board of Directors (the "Board") of Fitschools Foundation, a Pennsylvania non-profit corporation, (the "Corporation"), do hereby resolve as follows:

WHEREAS, the undersigned Directors of the Board (the "Directors"), having considered the advisability of voluntarily dissolving the Corporation, unanimously agree that it is advisable and in the best interests of the Corporation to wind-up, liquidate and formally and voluntarily dissolve the Corporation pursuant to Section 5972 of the Pennsylvania Nonprofit Corporation Law and other applicable provisions of the laws of the Commonwealth of Pennsylvania and adopt a plan for voluntary dissolution of the Corporation.

NOW, THEREFORE, BE IT AND IT IS HEREBY:

RESOLVED, that the Directors unanimously agree to and authorize the voluntary winding-up, liquidation and dissolution of the Corporation in accordance with the laws of the Commonwealth of Pennsylvania, including Section 5972 of the Pennsylvania Nonprofit Corporation Law; and

RESOLVED, that in order to accomplish the approved winding-up, liquidation and dissolution of the Corporation, the Directors hereby unanimously adopt and enact the following plan for the winding-up, liquidation and dissolution of the Corporation (the "Plan"):

1. After the adoption of this Plan, the Corporation shall not engage in any business or activities other than those required for the winding up of its affairs, the preservation of its assets, and the distribution of its assets in accordance with this Plan.

2. The Corporation shall promptly collect all amounts owed to it (if any) and shall pay or settle all claims against it (if any).

3. Following the adoption of this Plan, the President and Treasurer shall set aside a reserve fund (the "Reserve") in an amount determined by them to be sufficient to pay all unpaid taxes and miscellaneous fees and expenses (if any) in connection with the implementation of this Plan. The President and Treasurer are authorized to make disbursements from the Reserve by their mutual consent.

4. As soon as practical, and on the condition that no unresolved claims have been made against it, the Corporation, by and through its President and Treasurer, shall distribute all of its assets, net of the Reserve provided for in Section 3, to Healing Through the Arts, Inc., a Pennsylvania non-profit corporation and an exempt charity under Section 501(c)(3) of the Internal Revenue Code.

5. The balance remaining in the Reserve shall likewise be distributed to Healing Through the Arts, Inc., at such time as the President and Treasurer determine that all taxes, fees, and expenses have been paid.

6. As soon as practical after the distribution of assets of the Corporation to Healing Through the Arts, Inc., the President and Treasurer shall prepare and file with the Pennsylvania Department of Revenue an Out of Existence/Withdrawal Affidavit and shall prepare and file all documents required by the federal government, including a final tax return for the Corporation.

7. As soon as practical, the Corporation, by and through its President, shall execute Articles of Dissolution pursuant to, and in conformity with, the provisions of Section 5977 of the Pennsylvania Nonprofit Corporation Law, and cause such Articles of Dissolution to be filed with the Pennsylvania Department of State, Corporation Bureau.

8. The President and the Treasurer are further authorized, empowered and directed to do all other things and take such other actions and to file such other forms or documents as they in their mutual judgment determine to be necessary and appropriate to accomplish the winding-up, liquidation and dissolution of the Corporation intended by this Plan.


