4CORE oversaw the weatherization of 52 low-income homes from January through June of 2013 throughout the five county region encompassing Archuleta, Dolores, La Plata, Montezuma, and San Juan Counties with grant funds administrated through the Colorado Energy Office The administration and implementation of the Department of Energy Weatherization Assistance Program realized an estimated \$24,012 in annual utility bill savings for program recipients 4CORE's tenure of administering the low-income weatherization program ended in June 2013 due to the consolidation of the State of Colorado's weatherization Region 4 5 with Region 4 headquartered in Grand Junction, Colorado 4CORE continues to provide weatherization energy assessment services to non low-income residents and commercial properties in the region focusing primarily in La Plata, Montezuma, and Archuleta counties

4CORE developed four strategic focus areas to carry out their mission, including Energy Efficiency, Resource Efficiency Education, Innovative Solutions and the Energy Information Hub 4CORE developed goals under these areas and carried them out with program-specific activities The Energy Efficiency focus area included the Home and Commercial Performance Prescription Programs (HomeRx and CommercialRx) helped area residents and business owners save energy and improve health, safety, and comfort in homes and commercial buildings Partners included the City of Durango, Amerigas, and Atmos Energy (under the Energy Smart label), which provided incentives for assessments Fifteen homes were assessed in 2013 with a projected annual savings of \$6,990 As part of the Resource Smart Business Program which advances the efficiency and sustainability of local businesses, 14 businesses became certified savings an estimated \$30,100 and reducing emissions by 230 metric tons through funding from the Environmental Protection Agency, Climate Showcase Communities Grant The Resource Efficiency Education focus area includes the Healthy Homes Program initiated by 4CORE this year This program provides indoor air quality information to low-income households and is funded by an EPA Environmental Justice Grant and a Colorado Department of Health and Environment Radon Grant 4CORE also hosted 17 trainings and open houses highlighting sustainable building practices under this focus area The Innovative Solutions focus area supported the Solarize La Plata Campaign, with over 287 homes signed up in 2013 with the goal of installing 100 PV systems in 2014 A 15 member all volunteer committee oversaw this campaign which was funded by the City of Durango, the Ballantine Foundation, and with referral fees paid by five local solar installers The Alternative Fuel Working Group also falls under this focus area, where 4CORE faciliated quarterly meetings to discuss alternative fuels for regional fleets with support from La Plata County Energy Council, BP America, the Colorado Energy Office, and Refuel Colorado Under the Energy Information Hub 4CORE newsletter circulation increased to three times per month disseminated to 1,500 subscribers 4CORE also responded to 31,722 information requests about resource efficiency and continued to update its website with current sector relevant and timely information
