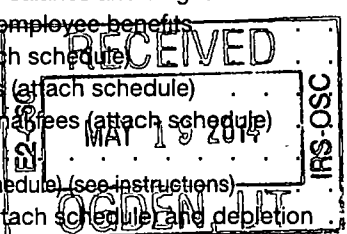

In 2013 our average monthly contributions were \$2580 and our average monthly expenses for carrying out our routine charitable activities were \$2514, a surplus of \$66 per month.
