We provided a sanctuary component to our rescue by providing care for dogs that are highly unadoptable but are not terminal (They need food and shelter andvet care until they pass away or until a home can be found which occurs at times but these dogs are slow if not impossible to adopt, such as those with Cushingsor Addison's disease or dogs with medical issues that are not terminal but need some care.
