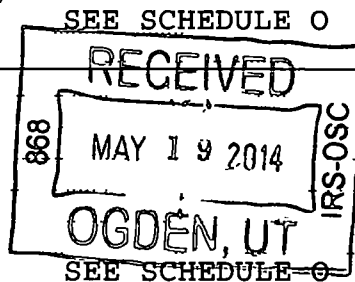





OR INDIRECTLY, ON A PERSONAL BENEFIT CONTRACT.
