	DURING 2013 AND THROUGH THE FORSAKEN CHILDREN'S PARTNERSHIP WITH THE ONESIMUS CHILDREN DEVELOPMENT ASSOCIATION (AN ETHIOPIAN NGO), THE ONESIMUS DROP-IN CENTER IN ETHIOPIA WAS FUNDED, ALLOWING IT TO OPEN ITS GATES TO COUNTLESS CHILDREN LIVING ON THE STREETS AND THOSE IN DANGER OF JOINING THEM. THE FORSAKEN CHILDREN ESTIMATES THAT APPROXIMATELY 2,000 CHILDREN AND ADULTS ARE IMPACTED THROUGH THE DROP-IN CENTER EACH YEAR. ADDITIONALLY, THE KOTA GANATE HATCHERY WAS ESTABLISHED TO CREATE A SUSTAINABLE IN-COUNTRY SOURCE OF REVENUE FOR THE NGO AND STRENGTHEN THE SURROUNDING COMMUNITIES. KOTA GANATE HAS DEVELOPED AS A WORKING FARM, IMPLEMENTING PROVEN SUSTAINABLE FARMING PRACTICES TO INCREASE THE PRODUCTIVITY OF THE LAND THROUGH DEMONSTRATION, TRAINING AND TECHNICAL ASSISTANCE. KOTA GANATE HAS AND WILL TRANSFER THESE PRACTICES TO FARMERS IN THE AREA. THE FARMERS WILL THEN BE ABLE TO INCREASE THE PRODUCTIVITY AND PROFITABILITY OF THEIR LAND WITHOUT HAVING TO ASSUME THE RISKS INVOLVED WITH DEVELOPING NEW TECHNIQUES. ADDITIONAL PROGRAM ACCOMPLISHMENTS INCLUDE EMPLOYMENT OF 35 ETHIOPIAN STAFF TO HELP REHABILITATE STREET CHILDREN AND TO MANAGE AND WORK ON THE KOTA GANATE FARM AND HATCHERY, OVER 250 CHILDREN IN POVERTY (MANY FORMER STREET CHILDREN) WERE ABLE TO ATTEND SCHOOL, 300 CHILDREN ATTENDED THE ONESIMUS CHILDREN'S CONFERENCE AND HEARD THE GOSPEL, MANY CHILDREN AND ADULTS CLAIMED TO UNDERSTAND AND ACCEPT THE GOSPEL OF JESUS CHRIST, OVER 60 CHILDREN WERE DISCIPLED BY ONESIMUS TEAM MEMBERS, MORE THAN 10 FORMER STREET CHILDREN WERE REINTEGRATED INTO THEIR FAMILIES, MANY FORMER STREET CHILDREN FOUND REFUGE IN ONESIMUS HALFWAY HOMES, THE KOTA HATCHERY BEGAN HATCHING CHICKS TO SELL IN THE LOCAL MARKET.
