At our retreat center (Wonderwell) we offered training in Tibetan Buddhism through 1) 24 Buddhist meditation retreats that ranged from one weekend to one month, 2) a weekly meeting of meditation and Buddhist study, 3) "Dharma Sunday" - a monthly all day program of meditation and Buddhist study, and 4) the "margha program" - a formal, multi-year study program in Buddhist meditation with over 100 students. These were all overseen by "Lamas" (teachers/ministers) trained in the Tibetan Buddhist tradition.

In Cambridge MA we pay for the use of a local church building for a weekly meeting of meditation and Buddhist study.

Pursuant to the bylaws in effect at that time, they were amended by vote of the Board of Directors and Teachers Council at a joint meeting called for that purpose on September 9, 2013, which vote was ratified by the membership at special annual meetings called for that purpose.

Form 990, Part VI, Section A, Line 6 - NDF had members who had paid the membership fee as set by the Board of Trustees pursuant to the prior and current bylaws.

Form 990, Part VI, Section A, Line 7a - Under the previous by-laws, teacher members elected 4 directors and lay members elected 3 directors. Under the current by-laws, candidates for election to the board are nominated by a 2/3's vote of the Board, subject to the approval of the Spiritual Director.

Form 990, Part VI, Section B, Line 10b - We have local groups that meet weekly for Buddhist meditation and study in Cambridge MA, Philadelphia PA, and Springfield NH. We don't document any procedures for this, although NDF does have an official prayer book.

Form 990, Part VI, Section B, Line 11b - The Treasurer distributes a copy of the return (except for the Schedule B details) to all the Directors for comments two weeks before filing the return.

Form 990, Part VI, Section B, Line 12c - We are a small organization with only a small number of transactions that could potentially be conflict of interest, so these transactions are all reviewed by the Board.

Form 990, Part IX, Line 11g - This money is paid to visiting Buddhist teachers, cooks hired for the retreats Wonderwell's cook cannot cover, the cleaning service, and contractors for Wonderwell repairs and maintenance. Some of this money was also paid to Willa Miller for her Buddhist teachings/retreats before she was employed as NDF's Spiritual Director.
