For education, panels of industry experts made presentation. For philanthropic and investment opportunities, ideas were presented to accredited investors.

The Wedgwood annual meeting retreat was held on October 23 to 25 in Nashville TN, with an emphasis on seeding culture with artists and projects that will make an impact on the "good, true, and beautiful for the common good." The agenda of the event started with a seated dinner, led by Jack Heaslip. The next day was spent in seminars with cultural experts in music, film, and theater, as well as presentations by our sector liasons about new project investment opportunities. The event ended its second evening with a concert by our Wedgwood granted and supported artists. The event concluded with a roundtable discussion with philanthropists, investors, and industry experts, on the impact of their contributions.
