Meals are prepared and served every Thursday evening and Saturday morning by teams of volunteers from surrounding churches, schools, service clubs and businesses. Representatives from several different resource agencies are often available to give our guests the opportunity to ask questions, receive information and meet with professionals. We serve an average of 210 people per week.

Back to School BBQ and Health Fair - Held in August, this event service over 800 children this year. MVCC gives families the opportunity to receive free backpacks, school supplies, immunizations, health screenings, dental checks, clothing and hair cuts as they prepare for the new school year.
