COMMUNITY AID IS DEDICATED TO IMPROVING THE QUALITY OF LIFE FOR THE INDIVIDUALS AND FAMILIES IN THE LOCAL COMMUNITY BY PROVIDING CASH GRANTS TO LOCAL SCHOOLS, CHURCHES, SYNAGOGUES, TEMPLES AND NON-PROFIT ORGANIZATIONS. IN 2013, 922 GRANTS WERE GIVEN TO 248 NON-PROFIT ORGANIZATIONS WITHIN THE SURROUNDING COMMUNITY TO SUPPORT IMPROVING THE QUALITY OF LIFE IN THAT AREA.
