See Schedule O Research The Foundation's primary focus is to support the Linda Crnic Institute for Down Syndrome, the first academic home in the United States committed to research and medical care for people with Down syndrome Grants to the Linda Crnic Institute totaled \$500,000 in 2013 The research conducted by the Institute focuses on sleep apnea, physical delays, Alzheimer's disease, congenital heart disease, and autism - diseases and conditions that a large number of people with Down syndrome have The Foundation also supports the Crnic Institute's Sie Center for Down Syndrome to provide the best multidisciplinary care for children with Down syndrome The Sie Center is working to update medical guidelines for children with Down syndrome, and will help to ensure that families, doctors and other healthcare providers have access to updated information

Education The Global Down Syndrome Educational Series was launched in 2006 and brings nationally and internationally recognized Down syndrome experts to Colorado for two full days of lectures The Educational Series was replaced in 2013 by a Research and Medical Care roundtable that took place in conjunction with the National Down Syndrome Congress Convention in Denver, Colorado led by an NIH keynote speaker Approximately 400 attendees from across the country attended, of which 80% were self-advocates and family members and the rest were professionals The roundtable was a full day conference covering cutting-edge research and best-practices in medical care, including a focus on prenatal testing, basic research, Down Syndrome, Alzheimer's disease, and general medical care
