The organization's primary exempt purpose is to provide meaningful outdoor education experiences for youth. This is done through curriculum-based multi-day wilderness river programs that incorporate healthy risk-taking, leadership building, academic lessons, team-building exercises, and conservation education.

28 In 2013, GOALS worked with children from all over the country to design and implement customized outdoor experiential learning opportunities for kids between 4th and 12th grade. The number of children we serve continues to increase, as does the scope of our programming. In 2013, we offered our first 10-day program through Labyrinth, Stillwater, and Cataract Canyons - as well as our first program on the Rogue River in Oregon. We have partnered with a new outfitter that creates additional opportunities for programming on rivers we haven't explored in the past, and opens new geographic areas for youth recruitment. GOALS programs in 2013 explored Desolation, Gray, Lodore, labyrinth, and Stillwater Canyons of the Green River as well as Ruby, Horsethief and Cataract Canyons of the Colorado River and the Wild and Scenic Section of the Rogue River. We are able to offer such wide programming options through partnerships with Adventure Bound in Grand Junction, CO, Sheri Griffith Expeditions in Moab, UT and ARTA in Groveland, CA. In addition to increasing our program options, GOALS continues to solidify the educational experiences we provide by enhancing our curriculum and improving the training we offer to GOALS program leaders before their program launch.
