Time to Revive, Inc. (TTR) The vision of Time to Revive is to urge believers to embrace their relationship with Jesus and to share the Truth that transforms lives. It is essential that the Church in America awaken now because Jesus will return soon to bring salvation to those who love Him and who are living for Him and we want to get ready for His return, and we want get our communities ready, too. Time to Revive, Inc. is exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code. TTR's revenues come primarily from individual charitable contributions.

Time to Revive seeks to spark revival through six phases. This entire process is dependent on the leading of the Holy Spirit, because God brings true revival.

City Ministry:

Phase 1—scoutCITY – When we are invited to a city and the Lord prompts the team, a scouting trip determines if this city is THE city for this state that God wants us to target. Time to Revive only travels to one city/region per state. The scouting trip also solidifies the key instigators for the revival in that state. If the Lord does not confirm that this is the city, Time to Revive does not move forward.

Phase 2—prepCITY – Three to five trips are conducted to research the city and prepare for the next phase and praying intelligently for revival. The prayer team grows during this time.

Phase 3—prayCITY – During a week of prayer, the team asks the Lord, “How do You want us to reach this city?” If the Lord answers, then we begin the next phase of training. If He does not answer, we continue praying or wait to return to the city.

Phase 4—trainCITY – Four to five trainings are hosted to prepare the team to engage the city with the Gospel of Jesus Christ as revealed by the Holy Spirit during the prayer week.

Phase 5—engageCITY – Now that the team is equipped; a week of intense outreach sparks ongoing work in the city. This week is a catalyst for ongoing evangelism and discipleship in the city that spreads throughout the entire state.

Phase 6—followupCITY – Follow-up is necessary for the work to continue in the city and spread throughout the state. Time to Revive continues to monitor the work through ongoing dialog and visits as led by the Holy Spirit.

General

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make

estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of these financial statements and the reported amounts of the revenues and expenses during the reporting period. Actual results could differ from those estimates.

Income Tax Status

The Organization is not a private foundation and qualifies as a tax-exempt organization under Section 501(c) (3) of the Internal Revenue Code and therefore, has no provision for income taxes. Any violation of these regulations could result in the Organization losing its tax-exempt status.

Cash and Cash Equivalents

Cash and cash equivalents consist of operating cash accounts and money market accounts.

Financial Statement Presentation

The Organization follows Accounting Standards Codification (ASC 958) No. 958, "Financial Statements of Not-For-Profit Organizations." Under ASC 958, the Organization is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets. Unrestricted net assets are those that are not subject to donor-imposed stipulations. Temporarily restricted assets are subject to stipulations that will be met by actions of the Organization or the passage of time. When restrictions expire, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restrictions. Permanently restricted net assets are those that must be maintained indefinitely by the Organization as stipulated by the donor. There were no permanently restricted net assets as of December 31, 2013.

Fair Value Instruments

The organization defines fair value within a framework established by generally accepted accounting principles. The framework includes a three-tier hierarchy for measuring fair value as follows: level 1 – quoted market prices in active markets; level 2 – inputs other than quoted prices that are directly or indirectly observable or level 3 – unobservable inputs where there is little or no market activity. The fair value of the Association's investments in the accompanying financial statements was determined using quoted prices from active markets (level 1).

Investments are stated at fair market value as determined on the last day of the fiscal year. Changes in market value are reflected as unrealized gains or losses.

Property and Equipment

The organization capitalizes property in excess of \$500. Purchased property and equipment are stated at cost. Donated property and equipment are stated at fair market value on the date of donation. If donors stipulate how long the assets must be used, the contributions are recorded as restricted support. In the absence of such stipulations, contributions of property and equipment are recorded as unrestricted support.

Depreciation is provided over the estimated useful lives of the respective assets on a straight-line basis. Routine repairs and maintenance are expensed as incurred.

Depreciation expense for the year ended December 31, 2013 totaled \$9,907.

Contributions

All contributions are considered available for the general programs of the Organization, unless specifically restricted by the donor. The Organization reports monetary gifts as temporarily restricted support if they are received with donor stipulations that limit the use of the donated assets or are subject to time restrictions. Unconditional promises to give, which do not state a due date, are presumed to be time-restricted by the donor until received and are reported as temporarily restricted net assets. A donor restriction expires when a stipulated time restriction ends, when an unconditional promise with an implied time restriction is collected, or when a purpose restriction is accomplished. Upon expiration, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restrictions. Restricted contributions received in the same year in which the restrictions are met are recorded as unrestricted support at the time of receipt.

Fund-Raising Expense

Total fund-raising expense for the year ended December 31, 2013 was \$40,686. The ratio of expenses to amounts raised is computed using actual expenses and related contributions on an accrual basis.

Functional Allocation of Expenses

The costs of providing the programs and activities have been summarized on a functional basis in the statements of activities. Accordingly, certain costs and expenses have been allocated among program expenses, fund raising, and general and administrative expenses.

Subsequent Events

Events have been evaluated through June 20, 2014 the date the financial statements were available for release, and management has determined that no additional disclosures are required.
