Our Vision is to serve Christ by establishing a church network within Greater Austin that will meet the emotional, physical, and spiritual needs of those affected by disaster. We will accomplish this vision by building a communication infrastructure within churches, ministries, and businesses, to enable and empower the body of Christ to organize, mobilize, connect, prepare, train and respond quickly in the event of a disaster.

In 2013, ADRN's network of churches provided emotional, spiritual and physical care to an estimated 7,000 survivors of the West Texas Explosion, the Moore Oklahoma Tornado and Central Texas Floods. ADRN managed and coordinated over 3,000 volunteers provided over 22,000 hours of assistance with clean-up, home repair, administrative support, communications, call center staffing, chaplaincy, sponsoring families and providing emotional and spiritual care. ADRN's church network sponsored 388 families from the Central Texas floods, providing water, food, shelter, transportation, and other essential physical items (trailers, gift cards, building supplies) to meet the immediate and long-term needs of these families. ADRN also helped establish a network of churches in Waco, Texas that sponsored 268 families from the West Texas Explosion and in Moore, Oklahoma that sponsored over 300 families from the Moore Tornado. ADRN is also a partner with the Central Texas Red Cross, with whom we sponsored many additional families affected by fire devastating their homes or apartments.

ADRN has an extensive training program for volunteers to empower them to become emotionally, spiritually and physically ready. ADRN offers 18 training classes in disaster response, of which 11 are FREE. ADRN's 2013 training attendance was 3,123 participants. 2013 Trainings included: Community Emergency Response Team (CERT) training, Critical Incident Stress Management (CISM) training, CPR/First Aid/AED, Preparedness Peace for Individuals and Families, Incident Command Training, Call Center Training, Shelter Training, Psychological 1st Aid Training, ICS-100 & 200 training, and four spiritual trainings; Conflict Resolution in Times of Disaster, Biblical Readiness, Psalm 91, the Protection of the Lord, and Prayer, Care and Share to name a few.

The goal of sponsoring families through Tt emotional, spiritual, and physical needs will be identified and met. Every church that adopts a family assigns one person (Disaster Relief Shepher worker to walk with them throughout the entire relief process until their immediate and sometimes long-term needs are met. Typically, a church wil support but financial support to meet the physical needs quickly. Whatever financial support a church cannot provide an individual/family that has additional funds from ADRN to support small to very large physical needs such as a car, trailer, mobile home home, rebuilding materials or the reb that partnering with the local churches on the network will typically match, double or triple the amount of funds given to help a family in need vs. g will provide gift cards directly to a family or individual in need if a great and immediate need arises such as food, water, clothing, shelter, etc. As a churches, there is a higher amount of accountability and assurance that funds are used appropriately and in accordance with their given intent.
