The funds raised in 2013 allowed Research Down Syndrome to grant \$305,321 in awards in 2013 to leading Down syndrome cognitive research institutions across the country and to support scientific meetings.

Research Down Syndrome interacted with the National Down Syndrome Research Consortium, national Down syndrome organizations, an affiliation of Down syndrome community associations, individual Down syndrome associations nationwide, and other members of the Down syndrome community, along with the broader public, to raise awareness of Down syndrome cognitive research and provide updates on the progress of this research.

In addition to supporting the foundation mission of spreading awareness of Down syndrome cognitive research and raising funds to support these scientific studies, Research Down Syndrome in 2013 continued to be a recognized national leader in advocating for increased life opportunities for persons with Down syndrome. Research Down Syndrome participated in national forums to advocate for increased public support of this research, and to engage with other participants in the Down syndrome research community to develop programs that will assist research efforts move from basic biomedical research to clinical trials.
