Shelter equipment, fixtures, and supplies--

FOTAS funded architectural and engineering plans and a large portion of the fixtures, equipment and landscaping for a new county animal shelter completed in March 2014. The new shelter is twice as large as the old shelter with vastly improved sanitary conditions to prevent disease and encourage adoption. FOTAS also funded miscellaneous supplies and small repairs for the old shelter before the new shelter was completed.

Dog transfers to no-kill shelter--

Due to gross over-crowding at the county animal shelter, FOTAS worked aggressively to transport as many adoptable dogs as possible to no-kill shelters out-of-state. The transfer program includes an extensive network of volunteers who foster dogs until they are old enough and healthy enough for transport. In 2013, FOTAS funded transportation for 652 dogs to no-kill shelters for adoption.

Spay and neuter assistance program--

To reduce the number of unwanted animals euthanized at the county animal shelter, FOTAS funded spay and neuter surgeries for approximately 391 county dogs and cats. Spay and neuter assistance is a long-term program to eliminate pet overpopulation which causes over-crowding and high euthanasia rates in the county animal shelter.
