Runa Foundation looks for new ways to value tropical forests that benefit local people and the forest ecosystem. Runa Foundation focuses on three main programmatic areas: 1) Fair Markets, 2) Building Knowledge, and 3) Ecosystems.

Fair Markets - Runa Foundation works with 2500 indigenous farmers in the Ecuadorian Amazon that produce quayusa tea, a newly commercialized tea like plant that is native to the region. Runa Foundation supports these farmers in the creation of 10 Fair Trade certified producer cooperatives. Runa Foundation provides technical assistance and capacity building to these groups so they can comply with Fair Trade standards. In 2013, Runa Foundation focused three particular areas of support - the creation of cooperative work plans, communication strategies, and financial literacy. Runa Foundation also supported these cooperatives through the annual Fair Trade Audit conducted by Scientific Certification Systems under Fair Trade USA's standard for independent small holder farmers. Runa Foundation's Fair Markets program is overseen by Michael Conroy who is an economist that is currently the Chairmand of the Board of Forest Stewardship Council and was formerly the President of TransFair, the Fair Trade Labeling Organization.

Building Knowledge - Runa Foundation is supporting the work of a Peruvian non-profit organization, Asociacion Civil Rios Nete, to develop a research center focused on the research and development of native plant medicines. This project works in conjunction with indigenous health practitioners to identify ancestral knowledge of native plants for positive potential health benefits. In 2013, Runa Foundation put together a special advisory board of leading US oncologists to oversee preliminary research on the use of native plants in cancer treatment.

4c (Code:) (Expenses \$ 68,360 including grants of \$ 64,626) (Revenue \$)

Ecosystems - Runa Foundation focuses on research intended to better manage agroforestry systems in the Amazon. Agroforestry systems are agricultural systems that mimic forest ecosystems that deliver a variety of benefits to both local people and the forest ecosystem by creating a diversified source of income and food for local people while also protecting crucial habitat for forest animals and maintaining important stocks of carbon that mitigate climate change. Runa Foundation's ecosystem program is overseen by Dr. Florencia Montagnini, a senior researcher at Yale University and Yolanda Kakabadse, the President of WWF (World Wildlife Foundation) International. Runa Foundation conducts this research both in the Ecuadorian Amazon as well as in the Peruvian Amazon through our partner organization Rios Nete.

Monitoring of funds - Runa Foundation has entered into a specific project-based contract with Asociacion Rios Nete that has clear deliverables, a timeline, and a contractual obligation for Asociacion Rios Nete to disclose quarterly the use of funds as well as to maintain a bookkeeper and adhere to all Peruvian laws. Each quarter the Executive Director of Runa Foundation reviews the financial reports of the use of funds and reports to the board in quarterly board meetings. Runa Foundation has hired an American consultant to support Rios Nete in its execution of the project including financial management. The Executive Director holds monthly virtual conferences with the Executive Director of Rios Nete and the consultant to review progress of the grant.

Accounting Method - Asociacion Rios Nete maintains its books for all of the uses of funds received by Runa Foundation in its office in Tarapoto. It has a full-time bookkeeper who must ensure that Rios Nete maintains its contractual obligations with Runa Foundation as well as its obligations.

Section III, Question 4d, Other Program Services - Runa Foundation maintains a volunteer and internship program in Ecuador and Peru. Students and other interested adults travel to Ecuador and Peru to assist in a variety of our projects. Runa Foundation charges \$200/week and most volunteers and interns stay for a minimum of 6 weeks. The program is primarily educational. Interns and volunteers learn about the livelihoods of local people in the Amazon as well as the ecological context of the region.

Section VI - Review of 990 - The Executive Director sends an electronic copy of the 990 to all members of the board. They have 2 days to review to give consent to submit to the IRS. The entire board must agree before sending the 990.
