This amount was granted to The Montana Land Reliance (MLR) per a grant request dated February 12, 2013. The grant covered MLR's costs related to 1) stewardship/monitoring/enforcement of the conservation easements it held and monitored in 2013 (\$282,382); 2) outreach activities to educate landowners, public officials, and the general public (publications, travel, printing) (\$162,638); and 3) legal expenses incurred with existing conservation easement enforcement (\$23,392).

The Montana Land Reliance Foundation received grants from The Montana Land Reliance (MLR) totaling \$121,200 during the tax period.

These monies are invested to generate income for MLR's operations, education and outreach activities, and stewardship and monitoring activities. There was \$50,200 invested into the Foundation's Land Protection Fund, \$70,000 invested into the Foundation's Education and Outreach Fund; and \$1,000 invested into the Eastern Montana Fund.

MLR, per an Intercompany Services Agreement executed by the two related entities, performs accounting and administrative services for the Montana Land Reliance Foundation. The Foundation paid the MLR \$30,000 during this tax period for the performance of these services.
