Spiritual Growth Producing a 24-hour, spiritually-engaging, non-commercial radio format that fosters spiritual growth in the lives of individual listeners, leveraging both Christ-centered music and practical Bible teaching. The resulting spiritual growth in each individual is foundational to our purpose of advancing the gospel of Jesus Christ. There were over 1,000 written interactions with listeners, including prayer requests, and life-changing impact stories. 17 compelling Bible teaching programs and short features brought spiritual perspective on marriage, parenting, finances and life challenges. 500 people downloaded our prayer guide each month and committed to growth in their prayer lives. Over 1200 listeners received our music advisory team survey each month, providing valuable feedback to keep our song list relevant to listener preferences. Online listening exceeded 418,000 hours and our informative website received approximately 900 visits daily.

Connection Fostering cooperation among churches and faith-based ministries by serving as a common connection point for information. Relationships are built with leadership of churches and faith-based ministries and information is gathered about their activities and then communicated through our website, on-air announcements and produced spots. Approximately 175 Nebraska churches, ministries and individuals had the opportunity to share highlights of God's work through ministry spotlights, morning conversations and other on-air segments. Ten ministries recorded one-minute impact stories which aired in daily rotations. Listeners connected with us over 1200 times regarding posting community events, on-air celebration announcements, and interactive contests. 6,100 people received our monthly newsletter, keeping them connected to local ministry opportunities and events. About 4600 received regular social media updates.

Mobilization Maximizing evangelistic opportunities by mobilizing listeners to new levels of spiritual advancement across denominational lines. Carefully selected high-impact opportunities and events are heavily promoted in order to call the listener to action. In 2013 some of these action points included 340 listeners committing to our daily prayer focus, 86 attending a marriage enrichment conference, 30 families taking training classes to become foster parents, over 200 families committing to regular prayer for foster children in Nebraska, over 400 people giving toward a project to stop human trafficking, about 75 listeners nominating someone for Nebraska Father of the Year, 30 mission trips being highlighted, and 30 kids in crisis receiving scholarships for summer camps.
