The organization developed and distributed safe water systems to a non-governmental organization in Uganda, TivaWater, and supported TivaWater's efforts in the region to educate entities and individuals in safe water systems. World Water Project assisted in distributing over 10,000 TivaWater home filters to homes and villages in Uganda and Guatemala. An estimated 100,000 people now have access to clean water. World Water Project continues to expand its partnerships in East Africa and Guatemala. In partnership with other non-governmental organizations, World Water Project hopes to distribute up to 5,000 more filters in 2014. In future years, the goal is to distribute over 10,000 filters per year.

In 2013, World Water Project assisted in developing Chicken City Farms, a 13-acre poultry school in Uganda that provides hands-on education to young men. In 2013, the organization recruited its first eight students who will graduate in 2014.
