BEPA PAYS AN HONORARIUM TO A TEAM OF "ANTI-LITTER VOLUNTEERS" WHO WALK THE MAIN ROAD FROM HORIZON TO MILESTONE COTTAGE PICKING UP TRASH THAT IS THROWN ON THE ROADSIDE. BEPA ALSO PURCHASES PLASTIC GLOVES AND PLASTIC BAGS FOR THE VOLUNTEERS. FISHERMAN'S FRIENDLY SOCIETY \$593 THE FISHERMAN'S FRIENDLY SOCIETY, WHICH IS RESPONSIBLE FOR THE DAY-TO-DAY PROTECTION OF THE BLUEFIELDS BAY MARINE SANCTUARY, RECEIVED FUNDS FOR GASOLINE USED TO PATROL THE BAY. BEPA ALSO SUPPORTED THE LIONFISH PROJECT, AN INITIATIVE TO ENCOURAGE LOCALS TO CATCH AND EAT THE LIONFISH, WHICH WAS THOUGHT TO BE INEDIBLE AND POISONOUS. THE LIONFISH IS AN INVASIVE SPECIES THAT HAS TAKEN OVER THE LOCAL WATERS WHILE DECIMATING THE LOCAL FISH POPULATION.
