Azerbaijani Artifacts
Azerbaijani Artifacts is a first-ever comprehensive English-language exhibition addressing Azerbaijani heritage. The exhibition is online but also easily adapted into display panels for exhibition by museums, community centers, libraries, and other venues. Foundation staff and volunteers have conducted extensive research, in consultation with experts on the Foundation boards and elsewhere, and have applied an audience-friendly approach. Supplemental materials include curriculum-based materials for students and a hands-on kit geared to children. The Foundation offers speakers for specific venues to add depth to the display.

Public Education and Artist/Scholar Support:
The Karabakh Foundation (KF) works to preserve, nurture, and share Azerbaijani culture. KF collects and preserves original artifacts such as costumes, carpets, coins, paintings and manuscripts. KF also serves as a resource clearinghouse for artists and experts with an interest in Azerbaijani culture, providing a network for exchange, as in the Cultural Diplomacy: A U.S. Model Facebook group, and a range of other resources. The Foundation also conducts performances and learning sessions in public schools, trains and empowers a network of "cultural ambassadors" to present Azerbaijani culture nationwide via international festivals and university expositions, and provides an Azerbaijan in a Box kit and curriculum-related materials to cultural ambassadors and to schools to facilitate hands-on learning opportunities.
