We hire veterinarians to provide free and low cost veterinary services to low income pet owners. This is the major part of our efforts at this time. In 2013 we treated 5,960 low income household pets, approximately the same as the previous year. We also provided free veterinary services for NYC Animal Control animals at the rate of 12.4 % of our net income. In addition we provided free services to low income pet parents at the rate of 35.64 % of our net income, and 11.85 % of our gross program revenue. Together, our total free services amounted to 23.24 % of our net revenue and 17.78 % of our gross revenue in 2013. As a result hundreds of NYC Animal Control animals were treated for free, including expensive surgeries, which made them adoptable into new homes rather than each animal costing NYC \$200 to intake, process, evaluate, board, and either adopt or euthanize. We also held four totally free vaccination days for low income pet owners as well as two totally free full veterinary service days for victims of Superstorm Sandy.
