During the 2012-2013 year, the OSF has successfully managed and grown several Mormon-themed podcasts including Mormon Stories, Mormon Matters, Mormon Sunday School, Gay Mormon Stories, A Thoughtful Faith, and Mormon Mental Health Podcasts. In most cases these podcasts have released either weekly or semi-weekly episodes on a consistent basis, and subscribers have steadily grown across the board. We have received consistent feedback from listeners of all the podcasts indicating high levels of satisfaction. At present, all of these podcasts rest in the Top 40 "most listened-to" Mormont-themed podcasts (according to iTunes), with Mormon Stories at #3, Mormon Matters at #5, Mormon Stories Sunday School at #16, A Thoughtful Faith at #27, Gay Mormon Stories at #36, and Mormon Mental Health at #38.
