This all volunteer organization receives most of its referrals from the Children's Mercy Hospital Network and the University of Kansas Hospital System. We help families with children in the hospital to cover such things as rent and mortgage payments, utility bills, and gasoline. We raise funds to help families in need to cover day-to-day expenses so they can focus on their child's health, rather than their financial shortfalls. Since its inception, we have helped 136 families by giving them over \$193,000.
