

Our Hen House provides resources that make it possible for everyone to get involved with changing the world for animals. These resources are delivered via the website, www.ourhenhouse.org, which received 172,054 unique visits and 465,770 page views in 2013 (compared to 2012, when [ourhenhouse.org](http://www.ourhenhouse.org) received 111,322 unique visits and 575,177 page views). Due to the quality of the information provided, each visit averaged 1.69 page views. Our Hen House produced 295 blog entries and 52 podcast episodes in 2013, and the organization was featured in 61 outlets, both in print and online. The weekly Our Hen House podcast received 296,249 total downloads and 199,479 unique downloads in 2013 (a sizable increase compared to 2012 which had 163,684 total downloads and 131,904 unique downloads).
