Chicks n Chaps was founded because we understand the emotional, physical and financial burden that fighting breast cancer brings to individuals and their families. We are dedicated to providing support and hope for individuals in local communities that need financial support in their fight with breast cancer.

We held four of main fundraisers this year, named "Chicks n Chaps Women's Rodeo Clinic". The women learn about the seven events of rodeo from top professional PRCA cowboys & cowgirls. They have the opportunity for roping lessons, to ride a mechanical bull, get a tour of the chutes and learn the ins and outs of the events of rodeo. However, more importantly, we have informational booths from the local hospitals, breast care organizations, and MRI companies, just to name a few. We have local celebrities, doctors, breast cancer survivors and other individuals speak to help educate and bring breast cancer awareness to all the attendees. In the five clinics, we held in 2013, we had over 750 attendees and over 100 volunteers.

We have generated our income from registration fees for the clinic, cash donations and in-kind donations. We solicit these donations through personal contact of our board members and other volunteers. We donate net profits to Tough Enough to Wear Pink of Montana, (TETWP) a qualified 501 (c) (3) organization.

All Committee members, volunteers, cowboys and cowgirls donate all their time. We plan, promote, and implement these events to raise money for individuals fighting breast cancer within their local communities. We have put the clinics on in the state of Montana, New Mexico and Arizona. We also assist committees in California, Washington, Oklahoma, and Idaho to put on clinics to benefit their local breast cancer foundations.

Chicks n Chaps was founded as a unique and fun way to raise money for people who are suffering from breast cancer. Since our inception we have continued to be directed by a mission of raising funds that are distributed by Tough Enough to Wear Pink of Montana who distribute their funds directly to the community where the money is raised, and directly to families and individuals who are impacted by breast cancer.
