

Provide families whom reside in low income communities quality, developmentally appropriate programs for early childhood. We currently hold a WV state License to provide care for 110 children at a time in the center. We operate from the hours of 6.30am to 11:30pm. This allows parents to have care and services while working and attending school during non-normal business hours.

The expense to utilities and rent for the childcare center are the largest expense. Providing services to children in WV requires a license through the WV DHHR. The regulations for the types of facility and facility safety measures are extremely important and demanding. We currently rent a center with the square footage to provide services to 110 children at a given time, but operate the center in many shifts. This allows the center to care for more than 200 different children in any given day. The facility also has a completely equipped kitchen. This allows our program to participate in the WV Child Nutrition Program. Though the building it's self does not provide revenue, the building is a licensing requirement that allows us to participate in funding from WV DHHR and WV Child Nutrition program. Almost all of our funding is from the two WV governmental agencies which help provide services for low income children. The revenue from WVDHHR is related to the building and also to employee payroll.

4b (Code:) (Expenses \$ 122566.67 including grants of \$) (Revenue \$)
Payroll is the second largest expense for our program. As stated before to receive funding through the WV agencies to aide low-income children we must comply with state regulations. One of the requirements in the staffing. You must have a certain amount of staff to care for the children. This staff must have training and background checks through the WV DHHR. The revenue listed above on 4a is also related to the payroll expense. The rent, utilities and staffing are some of the largest parts of the regulations. Without complying with these there would be no funding.

Children Meals - is the third largest expense for our program. We currently work with the WV Child Nutrition Program whom is an agency that works under USDA. The WV Child Nutrition Program requires that a program work under the regulations of the USDA to provide quality meals to children. Our center uses this program in the same manner as public schools. We follow the regulations of providing quality meals and meal education to children. In return the WV CNP helps reimburse the cost of of meals, labor, education for the children and staff, rental expenses for space used to conduct the program, supplies and such. They also provide programs to our staff and children that aid in nutritional program and physical fitness. The goal is to teach children the benefits and importances of nutritious meals and physical activity.
