

Summer Advantage USA: In 2013, Summit54 expanded its involvement with Summer Advantage USA to improve educational achievement by offering a 5-week summer program including rigorous academic instruction and enrichment activities. More than five hundred scholars completed the 2013 with a 98% attendance record, and gained an average of 3 months in reading skills and 2.8 months in math skills that would typically be lost during summer school breaks.

College Track: Summit54 continues its partnership with College Track to help motivated students to reach their goal of attending and graduating from college.
