SHE WORKED CLOSELY WITH THE YOUTH LEADERS OF TOGETHERNESS COOPERATIVE TO IMPROVE FARMING METHODS. SHE LED A TRIP WITH THE YOUTH LEADERS TO UGANDA TO LEARN SUSTAINABLE, ORGANIC, HIGHER YIELD PRACTICES. SHE ALSO FOCUSED ON HELPING THEM WITH THEIR COWS, AND PLANNING FURTHER LIVESTOCK INVESTMENT.
