As of December 31, 2013, the Foundation owned two properties consisting of approximately 276,000 Square Feet of building space on 44 acres of land Each property contains a Middle School for grades 7-8 supporting upwards of 1200 students per campus The middle school environment provides 42 classrooms including state-of-the art science labs focused on providing advanced curriculum teaching methods striving to motivate students to establish early career based education paths In addition to housing middle school students, the campuses also host vibrant Early Childhood opportunities in the form of a Pre-kindergarten facility with up to 400 preschoolers Each site provides high school level athletic facilities that service fully illuminated baseball, softball, soccer and football fields with satellite restroom/concession facilities In 2013, the first year of operations, each school achieved an enrollment of more than 900 and full enrollment of the Pre-kindergarten facilities The Foundation also provided athletic scholarships and teacher performance awards and support
