	Sustainable Fisheries Partnership Foundation (SFP) comprises approximately 50 staff and contractors working to engage and catalyze global seafood supply chains in rebuilding depleted fish stocks and reducing the environmental impacts of fishing and fish farming. SFP works in North America, Europe, Asia, and Latin America, and has recently begun to work on fisheries improvement in Africa. Wherever we work, SFP educates our partners by providing them with the current information and objective advice needed to achieve the necessary improvements toward future sustainability. (continued on Schedule O)(continued from page 2) Since its founding in 2006, Sustainable Fisheries Partnership has worked to improve fisheries that are not yet managed well enough to meet the standards of credible international arbiters of sustainability. SFP does this by educating major seafood buyers and producers that both need the products of these fisheries and are committed to sustainability in the fisheries from which they are sourcing. SFP engages the seafood industry to meet this challenge by helping less well-managed fisheries meet the sustainability requirements of major markets. In 2013, SFP partnered with a number of retailers, wholesalers, and restaurant chains, providing sustainable sourcing advice to key market players, and, in turn, applying their sustainable procurement commitments to drive improvement actions throughout the supply chain (SFP's current partner list can be found at www.sustainablefish.org). SFP sponsors annual Fisheries Forums in North America and Europe that provide opportunities for our partners and other stakeholders to meet, learn, share information and lessons learned, and decide strategies for achieving sustainable fisheries. The forums are specifically scheduled to prepare our partners for the annual seafood expos in Boston and Brussels, where they make many of their purchasing decisions. Participation in the Fisheries Forums has grown dramatically and they have become an important component of SFP's engagement with the seafood industry and other stakeholders with an interest in sustainable fisheries. One of the most important tools SFP uses to inform improvement in fisheries is its FishSource program—an online information resource that records the status of fish stocks and fisheries. SFP created FishSource (www.fishsource.com) so that fisheries experts around the world could openly share their public scientific and technical information and provide major seafood buyers with up-to-date, impartial, actionable information on the status of fisheries and the improvements that are needed to become sustainable. Currently, FishSource contains 1,369 live profiles of fisheries available to the public with another 679 in draft and under development. SFP helps to organize fish buyers into roundtables that take a direct interest in particular species and regions. These roundtables also oversee the creation of fishery improvement projects in their areas and monitor progress. There are already many roundtables operating for species such as tuna, whitefish, mahi and snapper while new roundtables are forming all the time. In addition to the industry-led projects promoted by SFP roundtables, there are also projects that SFP operates directly. Worldwide, SFP is catalyzing improvement in 50 fisheries and aquaculture areas.
