CLIMB CDC was selected as one of three sites nationally to participate in the Barista Training Program to benefit at-risk youth. Funding was provided by Starbucks and Schultz Family Foundation.

With funding for the AmeriCorps program provided by Volunteer Mississippi, CLIMB CDC completed renovations of homes for low-income families. AmeriCorps members also prepared and served meals to indigent Gulfport residents.

With funding from Baton Rouge Area Foundation and other donors, CLIMB CDC's Cafe Climb program trained and placed at-risk youth in employment, education or advanced training programs.
