In 2013, the Golden Hat Foundation, in accordance to its mission, successfully spread awareness of the intellectual capabilities of individuals with ASD and the need to provide those affected with the right opportunities and support so that they can flourish and be an active and integral part of their community and society in general. The Golden Hat Foundation started publishing its monthly newsletter distributed to thousands of subscribers every month, increased its presence and reach through social media and participated in numerous events for autism both small and large.

In December The Golden Hat Foundation held a concert in Carnegie Hall in New York that was centered on autistic individuals and their families. The Foundation distributed close to 600 tickets to families of those affected, to attend the event free of charge and giving families dealing with autism a chance to experience a high profile event in a safe and autism friendly environment.
