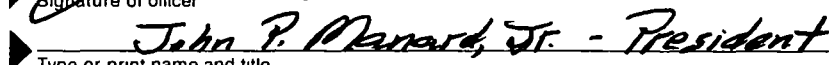

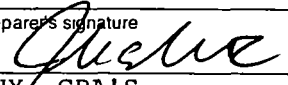

TRAINING PROGRAMS - AGES 10 THROUGH 18. THIS PROGRAM ALSO WILL REACH OUT TO FURNISH SAILING AND SAFE BOATING EDUCATION TO CHILDREN ENGAGED IN RECREATIONAL PROGRAMS RUN BY NORD, THE CITY'S RECENTLY IMPROVED RECREATIONAL DEPARTMENT, PARTICULARLY WITH REGARD TO SUMMER PROGRAMS.
