DC Diaper Bank continued to focus and grow its Diaper Distribution Program in 2013. This program continues to be the main
programmatic focus of the DC Diaper Bank. In 2013, the DC Diaper Bank leased a warehouse to support storage and distribution
of the diapers. We also expanded the number of partner agencies with which we work and, after starting distribution from the warehouse, increased
the number of diapers distribution in the community to an average of 45,500 per month. DC Diaper Bank works with a wide variety of partner
agencies providing services in DC, Maryland, and Virginia. These partner agencies include domestic violence shelter, teen
parenting programs, subsidized daycares, and schools.

In 2013, the DC Diaper Bank also began collection and distribution of other baby necessities such as baby wipes and other items. In 2013,

The DC Diaper Bank received a grant from the National Diaper Bank Network with the support of Huggies adding 250,000 diapers to the Diaper Distribution Program in addition to the number of diapers collected from individual supporters. The number of partner agencies to which the DC Diaper Bank distributes was increased from 15 to 16 agencies in 2013.
