But without it, not much can be done. Even well-funded larger institutions like universities and hospitals have gaps in their program services that can only be filled with private philanthropy. Good Charity starts where other charities leave off, facilitating amazing accomplishments of humanity by empowering champions on the ground level that rely on funding as the lifeblood of their programs.
