In some cases WCC's contribution helped sustain and strengthen the impact of worthwhile existing programs, in other cases to help launch new Christian outreaches consistent with our Mission. These efforts resulted in feeding programs, increased church attendance, safer environments for children -- and women at risk, Bible availability, video programs that provide greater understanding of Christian history and worldview, and a number of evangelistic outreaches.
