DURING THE TAX YEAR ENDING DECEMBER 31, 2013, THE COST OF DISCIPLESHP FOUNDATION (THE FOUNDATION) INADVERTENTLY AND INCORRECTLY MADE CONTRIBUTIONS TO TWO POLITICAL CAMPAIGN COMMITTEES. BOTH OF THESE CONTRIBUTIONS WERE MADE ON MARCH 5, 2013, RELATIVE TO A MAYORAL ELECTION IN THE CITY OF OMAHA, NEBRASKA. THESE CONTRIBUTIONS CONSISTED OF A \$1,000 CONTRIBUTION TO THE NABITY FOR MAYOR COMMITTEE AND A \$1,000 CONTRIBUTION TO THE MAYOR SUTTLE RE-ELECTION COMMITTEE.

THE FOUNDATION HAS REQUESTED ABATEMENT UNDER IRC SECTION 4962 OF THE EXCISE TAX ASSESSED UNDER IRC SECTION 4955 AS COMPUTED ON A FORM 4720. THE TAX YEAR ENDING DECEMBER 31, 2013, WAS THE FIRST YEAR OF OPERATION OF THE FOUNDATION, AND THE BOARD OF DIRECTORS/MANAGER WAS UNAWARE OF THE PROHIBITION AGAINST CONTRIBUTIONS TO LOCAL ELECTIONS. SUBSEQUENTLY, THE BOARD OF DIRECTORS HAS CONSULTED WITH ITS PROFESSIONAL ADVISORS AND HAS RECEIVED TRAINING AND INFORMATION RELATIVE TO PROHIBITED ACTIVITIES FOR THE FOUNDATION PARTICULARLY PROHIBITIONS AGAINST POLITICAL ACTIVITIES.

THESE CONTRIBUTIONS WERE A ONE-TIME OCCURRENCE DURING THE FIRST YEAR OF THE FOUNDATION'S OPERATION, AND WERE NOT THE RESULT OF ANY WILLFULL NEGLECT OR ANY DELIBERATE ATTEMPT BY THE FOUNDATION OR ITS MANAGER NOT TO FOLLOW THE STATUTORY REQUIREMENTS RELATIVE TO THE OPERATION OF THE FOUNDATION.
