IN 2013, ACAM AWARDED 59 GRANTS TO COMMUNITY ASSISTANCE MINISTRIES IN THE GREATER HOUSTON AREA. ACAM AWARDED 32 GRANTS FOR ORGANIZATIONAL AND PROFESSIONAL DEVELOPMENT PROMOTING SOUND PRACTICES IN NONPROFIT OPERATIONS AND PROGRAMMING, AND SUPPORTING ORGANIZATIONAL PLAN IMPLEMENTATION THROUGH TRAINING AND CONSULTING STIPENDS AND DIRECT GRANTS. ANOTHER 12 GRANTS WERE AWARDED TO MEMBERS FOR BUILDING INFRASTRUCTURE IN ORDER TO ACHIEVE BETTER OUTCOMES AND EMPLOY ENHANCED SERVICE MODELS. MEMBER MINISTRIES RECEIVED 12 GRANTS TO SUPPLEMENT THEIR SCHOOL SUPPLY PROGRAMS. ACAM ALSO DEVELOPED AN EMERGENCY SOLUTIONS COLLABORATIVE INITIATIVE WHICH RESULTED IN THREE SIZABLE GRANTS TO MINISTRIES STRENGTHENING THEIR HOMELESSNESS PREVENTION AND RAPID RE-HOUSING. IN 2014, ACAM AWARDED 32 GRANTS FOR ORGANIZATIONAL AND PROFESSIONAL DEVELOPMENT PROMOTING SOUND PRACTICES IN NONPROFIT OPERATIONS AND PROGRAMMING, AND SUPPORTING ORGANIZATIONAL PLAN IMPLEMENTATION THROUGH TRAINING AND CONSULTING STIPENDS AND DIRECT GRANTS.
