**FIRST AMENDMENT TO
TRUST AGREEMENT ESTABLISHING THE
LIFE AFTER SUICIDE FOUNDATION
(N/K/A THE HERBERT ADELMAN FOUNDATION)**

THIS FIRST AMENDMENT is made this 12 day of Nov., 2013, to the Trust Agreement establishing the Life After Suicide Foundation dated December 28, 2009, by and between IRWIN PRESS and ANDRA S. PRESS, of Chicago, Illinois, as Grantors, and ANDRA S. PRESS, of Chicago, Illinois, as Trustee (which Trust Agreement is hereinafter referred to as the "Trust Agreement").

WITNESSETH:

WHEREAS, the recitals of the Trust Agreement provide that the trust created under the Trust Agreement shall be known by such name as the Trustee shall from time to time designate by a written instrument duly executed by all of the then acting Trustees;

WHEREAS, Article III of the Trust Agreement provides that the Trust Agreement may be amended at any time and from time to time by written instrument signed and acknowledged by the Trustee, provided that no amendment shall authorize the Trustees to conduct the affairs of the trust hereunder in any manner or for any purpose contrary to the provisions of Section 501(c)(3) of the Internal Revenue Code;

WHEREAS, Article III of the Trust Agreement further provides that all instruments amending the Trust Agreement shall be noted upon or kept attached to an executed original of this Agreement held by the Trustee;

WHEREAS, the Trustee desires to amend the name of the trust created under the Trust Agreement and to amend the Trust Agreement in the manner hereinafter set forth; and

WHEREAS, ANDRA S. PRESS is the Trustee of the trust.

NOW, THEREFORE, in accordance with the recitals of the Trust Agreement and the provisions of Article III of the Trust Agreement, ANDRA S. PRESS does hereby, by the execution of this instrument, modify, alter and amend the Trust Agreement as hereinbelow set forth.

1. The trust created under the Trust Agreement shall hereinafter be referred to as "The Herbert Adelman Foundation" and shall cease to be known as the "Life After Suicide Foundation".
2. Section 1.4 of Article I of the Trust Agreement is hereby modified, altered and amended to read, in its entirety, as follows:

"1.4 The Herbert Adelman Foundation was established in memory of its namesake to address both the causes and socio-emotional consequences of suicide. Although the Trustee is authorized to make distributions for any Charitable Purposes, it is the wish of the Grantors, not amounting to any legal obligation, that in exercising discretion with respect to the distribution of income and principal, the Trustees may accomplish this goal by making gifts to Exempt Organizations (as defined in Section 1.9 herein) that concentrate on (a) public awareness and education, (b) the prevention of suicide, and (c) the counseling and support of survivors."

3. The Trust Agreement, except to the extent modified, altered and amended hereinabove, shall remain in full force and effect.


