CLIENTS WHO RECEIVE A HOMEOWNERSHIP CERTIFICATE MUST COMPLETE A MINIMUM OF 8 HOURS OF EDUCATION; 6 HOURS IN A CLASSROOM SETTING AND 2 HOURS OF ONE-ON-ONE COUNSELING WITH A HOMEOWNERSHIP COUNSELOR. IN 2013, NYMC GENERATED APPROXIMATELY 500 AFFORDABLE MORTGAGES TO CLIENTS IN NEW YORK CITY THROUGH ITS FIRST TIME HOMEBUYER PROGRAM.

NSP2: THE NSP2 PROGRAM CLOSED AS PLANNED ON FEBRUARY 11, 2013. A TOTAL OF 19 BUYERS USED NSP2 FUNDS TO CLOSE. AN ADDITIONAL 15 CLIENTS BECAME HOMEOWNERS BUT PURCHASED OUTSIDE OF THE PROGRAM. SIX BUYERS COMPLETED THE HPD REVIEW PROCESS BUT DID NOT HAVE TIME TO CLOSE ON THEIR QUALIFIED PROPERTY. OF 280 TOTAL APPLICANTS, 262 MOVED ON TO COUNSELING.

WE HAVE TRACKED 84 THROUGH HOMEBUYER EDUCATION AND 54 WHO COMPLETED THE COUNSELING AND LOAN APPROVAL PROCESS FOR CLIENT CERTIFICATION. THESE CLIENTS ARE READY TO PURCHASE HOMES BUT DID NOT HAVE TIME TO FIND A QUALIFIED HOME.

NYMC PROVIDED OVER 2,000 CLIENTS FORECLOSURE ASSISTANCE IN 2013. OF THESE 2000, OVER 200 CLIENTS HAD THEIR MORTGAGES MODIFIED, REFINANCED, OR BROUGHT CURRENT AND WERE ABLE TO STAY IN THEIR HOMES.
