Rapha Academy Fresh Start Childcare Center is a Christian preschool and aftercare program for infants beginning at 6 weeks through children 14 years of age. Weekday hours are 6:00 am to midnight, and Saturday hours are 6:00 a.m. to 6:00 p.m. 90 children received services in 2013, an increase of 11% from 2012. A summer program that included 6 weeks of recreational and educational field trips as well as an educational boot camp was included. Opportunities to learn were given to 2 interns from the Lorain County Community College Financial Aid Work Study Program, who provided 560 hours of service; 7 TANEF Summer Program workers provided 1,760 hours of service; 14 volunteers served as receptionist, maintenance, kitchen help and recordkeeping for a total of 3,500 hours.
